ELIGIBILITY CRITERIA

Class I-A/Class – I contactors, individual firms, partner ship firms, company, (registered with Karnataka PWD, CPWD) having suitable technical, financial and managerial capabilities satisfying the following conditions are eligible to apply.

i. Joint venture/Consortia, is not permissible. **ii.** Experience in construction of similar nature of works. **iii.** The Tenderer should have achieved in at least two financial years, a minimum financial turnover of not less than two times the estimated cost of the work in the last five years period. Certificate to the effect shall be furnished duly certified by Chartered Accountant. **iv.** The Tenderer should have satisfactorily completed as a prime contractor at least one similar work to an extent of 80% of the cost of the work in the last five years period. **v.** The assessed available Tender capacity shall not be less than the amount put to Tender. **vi.** EMD shall be in favor of **The Commissioner, MCC, Mysore** and may be in the form of Banker's cheque/Demand Draft/Pay Order in favour The Commissioner, MCC, Mysore payable at Mysore or specified small savings instruments pledged to The Commissioner, MCC, Mysore. Instruments having fixed validity issued as EMD for the tender shall be valid for 45 days beyond the validity of the tender. Conditional Tender & Tenders without EMD in requisite form will be summarily rejected as non-responsive.

vii. Non-transferable bid documents may be purchased from the office of the Superintending Engineer, Sayyaji Rao Road, Mysore-02 on payment of a non refundable amount of **Rs.50,000** payable in the form of Challan/Demand Draft for having credited the money into the **MCC account** (SBM Corporation Branch) along with requisition. Scope of the work:

Development of Road from Hardinge Circle to Bannimantapa. **(Dasara Procession Route ; via Sayyaji Rao Road) in Mysore City.**

Mysore City Corporation intends to develop the Road from Hardinge Circle to Bannimantapa (Dasara Procession Route ; via Sayyaji Rao Road) in Mysore City, on which Historical Mysore Dasara procession takes place.

The prime priorities of the project are to establish an international image for the Mysore Dasara Procession route and retain the splendour and grandeur of the heritage city. The entire facelift of the road is to match international standards in terms of quality of execution, durability and should adhere to all good international practices of engineering, implementation and project management.

The Components to be executed include fabrication of a variety of structures and amenities and include lamp posts, street furniture, amenities and landscaping, apart from road pavements and barricades.

The project also includes revamping and attaching heritage elements to tall masts and the provision of storm water drains and serviceable conduits for some infrastructure services.

The scope of the work also calls for the provision of lighting fixtures, solar panels and other electrical and mechanical components involved in water fountains, decorative water features. The provision of solar panels and LED based sensor lighting also forms a part of the project. Advertisement panels, LED display boards and road signages will also be covered under the scope of the project.

The total length of the road is approximately 5.2 kms and involves a total cost of approximately Sixteen crores of Indian Rupees. The project also includes within its scope the restructuring of five nodes and the development of a sculptured tower at Millennium circle (Near LIC).
